Dear 5.1.2e

Thank for your time and explanation yesterday on the reasons the Dutch government wants to change the mandate letter. We share the sense of urgency to get doses to COVAX as soon as possible.

We remain of the opinion that the optimal process for possible amendments to the Donation Mandate would be that these would be discussed first with Belgium and the EC then would be presented to JNJ and GAVI. The DSA has been extensively discussed with the facilitating member state, the European Commission and GAVI and please note we already took in account feedback from the Dutch team given earlier in the process (e.g. on 5.1.2f).

For your background, if the amendments you shared would be agreed by the other parties, we would have the remarks as attached. As discussed, most points relate to the relationship Belgium-NL, GAVI-NL and Belgium-GAVI-NL and we feel should be dealt with outside the framework if the Netherlands would need more comfort.

Again, we appreciate the input and hopefully we can find a way that will enable you to sign the mandate and join the COVAX dose sharing.
